Ending corporal punishment of children: The march of progress

Context

Corporal punishment is the most common and widely accepted form of violence against children, with vast numbers regularly experiencing it in multiple settings of their lives. Worldwide around 4 in 5 of all children aged 1-14 years are regularly subjected to violent punishment in their home, and corporal punishment in schools is also highly prevalent and accepted in many countries. Over fifty years of research has found strong evidence connecting corporal punishment with multiple short- and longterm harmful impacts for the child and society, including substantial economic costs.

Globally, only 14% of children are fully protected by law from corporal punishment in all settings, and 793 million school-age children live in countries where corporal punishment in school is not fully prohibited. The widespread social acceptance of corporal punishment helps to normalise violence in child rearing. As the smallest and most vulnerable members of society, children's right to live without violence must be ensured, as they need more, not less, protection from assault.

However, progress is accelerating! 40 years ago, only Sweden and Finland had passed a law banning all corporal punishment of children. In June 2024, Tajikistan became the 67th state to take this fundamental legislative step to protect children and uphold their rights. Prohibition in education and other settings also continues to grow. And there is evidence that when law reform is well implemented it is followed by an ongoing reduction in the acceptance and use of corporal punishment and other forms of violence across society.

Hosted by End Corporal Punishment, ChildFund Alliance, Save the Children and the World Health Organization (WHO), this satellite event provides an opportunity for senior politicians and policy makers to engage with the experiences of countries in enacting and implementing laws to prohibit corporal punishment of children, hear about the latest research on corporal punishment, and understand the critical role of CSOs.

The presence of ministerial delegations and other high-level participants to the Ministerial Conference represents a crucial occasion to foster country and stakeholder commitment to accelerate efforts towards the prohibition of corporal punishment of children in all settings. The experiences and knowledge shared in this satellite event will support countries in their progress towards prohibition and elimination of violent punishment of all children worldwide by 2030.
